1. \_\_\_\_\_ Payments are due every Friday by 5:30 p.m. Late fees of \$35.00 will be applied for late payments. If paying by Venmo, submit your payment by 5:30 p.m. even if we are closed on a holiday.
2. \_\_\_\_\_ If your child has a fever of 100.4°F or higher, diarrhea, a rash, conjunctivitis, or vomiting, they cannot return to daycare until they have been fever-free and off medication for 24 hours, in accordance with KDHE guidelines. Additionally, if your child has head lice or nits, they will not be allowed to attend daycare until they are lice and nit free.
3. \_\_\_\_\_ I understand that I need to contact my child's teacher, the owner Megan McKarnin, and the managers Ashley & Madison if I have any questions or concerns. We will handle everything confidentially.
4. \_\_\_\_\_ The attendance of my child/children at daycare is permitted only prior to 10:00 a.m., unless a physician's note is provided. Please note that children will not be admitted to daycare after 10:00 a.m., with the exception of Emerald City. For those in the Big Kid Building, it is essential to inform the teachers in advance of the child's arrival time to ensure proper accounting for activities and meals.

5. \_\_\_\_\_ Increased rates as of February 1st, 2025: (DCF rates remain the same)  
Poppy Seed Room: \$150.00 weekly  
Kansas Room: \$145.00 weekly  
Yellow Brick Road Room: \$140.00 weekly  
Over Rainbow Room: \$135.00 weekly  
Emerald City: \$125.00 weekly; after school \$60.00 weekly unless out of school.

6. \_\_\_\_\_ Closed days in 2025: January 1st, May 26th, July 3rd & 4th, September 1st, November 27th & 28th, December 24th, 25th & 26th, 31st, and January 1st, 2026. All must be paid for.

Emerald City/K-6th grade will be closed August 7th-12th (depending on school calendar) before school starts, and these days will not be charged to allow for preschool setup.

To void this contract, you MUST give Munchkinland & More two weeks' notice with payment. Also, if you have any questions, please do not hesitate to call/message Megan McKarnin-Owner/Director (6202281938).

We recommend that you put Megan McKarnin, Madison Ellis (Manager), and Ashley Cook (Manager) in a group message with your child's teacher so that we receive all messages.
